#### **NOTICE**

Pursuant to A.R.S, § 38-431.02, notice is hereby given to the members of the Arizona Board of Dispensing Opticians (Board) and to the general public that the Board will hold a meeting open to the public on:

The Board may go into executive session pursuant to A.R.S. § 38-431.03(A)(1) on agenda item 10 to discuss or consider personnel matters exempt by law from the public.

The agenda is subject to change up to 24 hours prior to the meeting. The Board Chairperson reserves the right to change the order of the items on the agenda, except for matters set for a specific time.
