1. Call to Order and Roll Call

Chairman Nyblade called the meeting to order at 10:33 am. In addition, roll call was taken. Board members present at this time were, Chairman Nyblade, Vice-Chairman Coleman, Secretary Mayes, Board member Pettit, and Board member Searle,

2. Conflicts of Interest

Secretary Mayes recused herself from item 5. B.

3. Review, Discussion and Approval of Minutes

A. Clear Vision Express – No Licensed Optician – Oro Valley

Vice-Chairman Coleman made a motion that Clear Vision Express is not exempt under The AZ State Board of Dispensing Opticians' Statutes and Rules in regards to other employees are being licensed. Board member Pettit seconded the motion and it carried.

Vice-Chairman Coleman made a motion that the Board works with Clear Vision Express in a Consent Agreement to resolve the outstanding violation of first-time offense fine of \$250 in 30 days in which time for them to find a licensed Optician for their establishment. Vice-Chairman Coleman amended the motion that was currently on the floor that the Licensed Optician be found by no later than June 30. Secretory Mayes seconded the motion and it carried.

B. Compliant against JCP/Nationwide Vision - Debbie Shutts

Vice-Chairman Coleman made a motion to dismiss Debbie Shutts complaints based on the lack of actionable violations on the eyewear she had made at JCP/Nationwide Vision. Board member Searle seconded the motion and it carried.
