 - 1. HB2637 Board of Dispensing Optician Repeal

Several Board members and board-related constituents met at the capitol yesterday, February 4, to voice their opposition to this Bill; the committee put the Bill on hold for now.

2. SB1235 - Health Profession Regulatory Boards; Membership, 32-1672, Page 6.

Exceed of Public Members over Licensee Members. Decreases, the number of licensed dispensing opticians from five to three, and increases the number of public members from two to four for the Dispensing Opticians Board

3. SB1037 - Health Boards: Fund Balance

The fund balance may not be more than two years of the Health Profession Regulatory Board's Annual Operating expenses plus five percent.
